#### Annex 2: WHO Tobacco/Arms Related Disclosure Statement for Non-State Actors

#### TOBACCO /ARMS RELATED DISCLOSURE STATEMENT FOR NON-STATE ACTORS1

Pursuant the WHO Framework of Engagement with Non-State Actors, WHO does not engage with the tobacco industry or non-State actors that work to further the interests of the tobacco industry. WHO also does not engage with the arms industry<sup>2</sup>.
